2.24.010 Created--Members. There is created a plan commission for the village, which shall consist of seven members appointed by the president with the approval of the board of trustees. (§1 of Ord. dated 6/2/69).

2.24.020 Term. The members to serve respectively for the following terms: one for one year; one for two years; one for three years; one for four years; one for five years; one for six years; one for seven years, and the successor of each member shall be appointed to serve for a term of five years. (§2 of Ord. dated 6/2/69).

2.24.030 Organization. The plan commission shall elect its own chairman, vice-chairman and such other officers as it may deem necessary. No member of the plan commission shall receive compensation for his services, provided that the village board of trustees may establish a compensation for the secretary of the plan commission and may provide such technical and other services to the plan commission as may be needed from time to time. (§3 of Ord. dated 6/2/69).

2.24.040 Powers and duties. A. The plan commission shall have such powers and exercise such duties as are provided for in Division 12 of Article 11 of the Illinois Municipal Code.

B. It shall exercise such other powers, germane to

the powers granted by this chapter, as may be conferred by village board of trustees. (§4 of Ord. dated 6/2/69).

2.24.050 Meetings. The plan commission shall meet at such times as it may by majority vote determine upon as regular meeting dates; or at any time upon call by the chairman thereof or by any four members thereof. (§7 of Ord. dated 6/2/69).

2.24.060 Records. The plan commission shall keep written records of its proceedings which shall be open to inspection by the village board of trustees at all times. (§6 of Ord. dated 6/2/69).

2.24.070 Conformance of subdivision plats required. No map or plat of any subdivision presented for record, affecting land within the corporate limits of the village, after the adoption of the official plan, shall be entitled to record or shall be valid unless the subdivision shown thereon conforms with the applicable provisions of the official plan and applicable requirements of the village zoning ordinance, on file in the office of the village clerk, and Title 16. (§5 of Ord. dated 6/2/69).
