VILLAGE OF TOLONO ORDINANCE NUMBER 88-1

AN ORDINANCE ESTABLISHING TRAFFIC-CONTROL REGULATIONS (AMENDMENT TO CHAPTER 10, SECTION 12 OF THE MUNICIPAL CODE)

BE IT ORDAINED by the President and Board of Trustees of the Village of Tolono, Champaign County, Illinois, that the provisions of Chapter 10, Section 12 of the Municipal Code entitled "Traffic Control Regulations", and all prior ordinances establishing specific regulations for stopping and yielding at intersections, are hereby repealed, and the provisions hereinafter set forth are hereby adopted:

10.12.010 Erection of Signs. The streets and alleys committee of the Board of Trustees of the Village shall cause appropriate stop and yield signs to be erected at intersections designated by this Ordinance, which signs shall be maintained during the term of this Ordinance as amended from time to time.

The driver or operator of any self or mechanically propelled vehicle who fails to come to a full stop at any intersection where there is a stop sign for the operator's lane of traffic, or who fails to yield the right-of-way to any vehicle in an intersection where there is a yield sign for the operator's lane of traffic, is guilty of a misdemeanor, and will be subject to a fine of not less than \$25.00, nor more than \$200.00.

THIS ORDINANCE shall be effective upon passage.
