

VILLAGE OF TOLONO
ORDINANCE NO. 90 -7

Amendment to Ordinance No. 87-5 entitled:

"AN ORDINANCE TO ESTABLISH RATES AND CHARGES
FOR THE USE OF AND SERVICE OF THE WATERWORKS AND
SEWERAGE SYSTEM OF THE VILLAGE OF TOLONO,
CHAMPAIGN COUNTY, ILLINOIS"

BE IT HEREBY ORDAINED BY THE VILLAGE BOARD OF TRUSTEES OF THE
VILLAGE OF TOLONO, COUNTY OF CHAMPAIGN, STATE OF ILLINOIS, THAT
ORDINANCE NO. 87-5 AS ABOVE ENTITLED, AS AMENDED BY ORDINANCE NO. 89-
2, BE FURTHER AMENDED ON THE DATE OF THIS ORDINANCE BY PROVISIONS
HEREINAFTER SET FORTH.

Amendment (A): Section 13.08.160 - Wastewater Service Charges.

Introductory Clause of Paragraph 1, Section 13.08.160 is
hereby amended to read as follows:

"Paragraph 1 Basis for Wastewater Service Charges: The wastewater
service charge for the use of and for services supplied by
the sewerage and wastewater facilities of the Village of
Tolono shall consist of a basic user charge for operation and
maintenance plus replacement, a debt service charge and a
surcharge, if applicable.

Beginning on the date of the within Ordinance, the EFFECTIVE
DATE OF RATES:

The debt service charge shall consist of a charge of \$4.60
per month per user for the first 2,000 gallons and \$1.61 per
1,000 gallons per month per user for all water usage above
2,000 gallons based on water usage as recorded by water
meters.

The basic user charge shall be based on water usage as
recorded by water meters for domestic sewage having the
following normal concentrations." (Subparagraphs a) through
e) inclusive remain unchanged.) (Definition of a surcharge
remains unchanged.)

"Basic user rate: There shall be and there is hereby
established a minimum charge and a basic user rate for the
use of and for service supplied by the Wastewater Facilities
and Sewerage System of the Village of Tolono. A minimum
charge of \$3.70 per month shall be applied to all users whose
water consumption does not exceed 2,000 gallons per month.
(In summary for first 2,000 gallons; Debt service charge is
\$4.60; Basic user rate is \$3.70; or a total of \$8.30 per
Wastewater Service.)

A basic user rate of \$1.69 per 1,000 gallons shall be applied to all users for water consumption in excess of 2,000 gallons per month." (In summary for each 1,000 gallons in excess of first 2,000 gallons: Debt service charge is \$1.61; Basic user rate is \$1.69; or a total of \$3.30 per Wastewater Service.)

All remaining provisions of Section 13.08.160 as amended, remain unchanged.

Amendment (B): Section 13.08.190 - Water and Sewer Rates.

"Paragraph 1 That there shall be and there are hereby established monthly rates and charges for the use and service of the combined waterworks and sewage system of the Village of Tolono, Champaign County, Illinois, based upon the amounts of water consumed as shown by water meters as follows:

For First	2,000 gallons	5.00
For All Over	2,000 gallons	2.50
	Per 1,000 gallons per Month	

Sewer Rates:

For First	2,000 gallons	8.30
For All Over	2,000 gallons	3.30
	Per 1,000 gallons per Month	

The minimum monthly charge for water and sewer service combined shall be \$13.30 per connection per month.

Where water service is used alone without sewer service, the monthly rates for water service shall be as follows:

For First	2,000 gallons	6.80
For All Over	2,000 gallons	2.50
	Per 1,000 gallons per Month	

There will be a minimum charge for water service for each connection of \$6.80 per month where sewer service is not provided.

All other provisions of Title 13 of the Tolono Municipal Code as previously amended, if not expressly modified hereby, shall remain in full force and effect. That if any section, paragraph, clause or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, this invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Ordinance.

This Ordinance and the rates and service charges established for user charges, shall be in full force and effect from and after its passage and approval and publication as provided by law.
