The Village of Tolono by its duly elected Board of Trustees has made the following determinations and adopts the following ordinance the date appearing below.

**WHEREAS:**

A. The Village of Tolono, through its Board of Trustees, is charged with promoting the health, safety, and welfare of its citizens.

B. In order to provide for adequate drainage for the community, the Village has determined that it is appropriate for it to regulate the construction and installation of driveways and culverts.

C. The Board of Trustees has determined that it is in the best interest of the citizens of the Village of Tolono that the Village adopt the following ordinance amending the prior driveway and culvert construction ordinance.

NOW THEREFORE, the Board of Trustees for the Village of Tolono hereby adopts the following amendment:

CHAPTER 12. 08 OF THE TOLONO MUNICIPAL CODE AS PREVIOUSLY ADOPTED UPDATED AND REVISED PERTAINING TO DRIVEWAY AND CULVERT CONSTRUCTION IS HEREBY AMENDED AS FOLLOWS:

12.08.010 Permit--Required. is hereby amended to read as follows:

12.08.010 Permit--Required. No driveway shall be constructed or altered or any culvert installed without a permit authorizing said construction, alteration, or installation from the Village. Construction of any driveway shall include the installation of a culvert meeting the specifications provided under this ordinance.

No driveway shall be constructed or altered or culvert installed without a permit authorizing said construction, alteration, or installation from the Village. All driveways shall include a culvert satisfying the specifications of this ordinance.

12.08.050 Specifications--Culverts. is hereby amended to read as follows:

12.08.050 Specifications--Culverts. Constructions of culverts shall be in accordance with the following:

A. Any culvert installed shall have a minimum length not less than that necessary to extend the entire width of the driveway and exceed the sides of the driveway by no less than two feet on either side. The culvert shall be installed in such a manner as to provide proper and customary drainage..

B. The diameter of any culvert used shall have a minimum size of at least 10 inches. Said culvert shall be constructed of non-corrosive, corrugated metal having a minimum strength of 16 guage.

The foregoing amendment shall have full force and effect from and after its passage and publication in pamphlet form as provided by law. The foregoing amendment shall further amend the drive way and culvert construction portion of the Tolono Municipal Code as specified having the effect of prevailing where the amendment conflicts with the existing terms of said ordinance. All other provisions of Chapter 12 of the Tolono Municipal Code, if not expressly modified under this amendment shall remain in full force and effect. If any section, paragraph, clause or provision of this ordinance shall be held to be invalid or unenforceable for any reason the invalidity or unenforceability of such section, paragraph, clause or provisions shall not effect any of the remaining provisions of this ordinance.


