ORDINANCE NO. 96-____ VILLAGE OF TOLONO, ILLINOIS ORDINANCE VACATING PROPERTY LOCATED ON DAGGY AVENUE

WHEREAS:

- A. The Village of Tolono, by its Board of Trustees hereinafter "Village", is charged with serving the interests of its citizens and advocating the health and welfare of the community; and
- B. Grand Prairie Co-Op, Inc. of Tolono, Illinois, an Illinois Corporation, has requested that the Village vacate a portion of what is commonly known as Daggy Avenue which is located within the Village corporate limits;: and
- C. The proposed vacated property includes a portion of land which is not used nor needed by the members of the public and serves no other interest to the Village and that the vacation of said property would significantly assist Grand Prairie Co-Op which is a large employer in the Village and would, as a result, accommodate an expansion of its facility to the benefit of the citizens of the Village; and
- D. The Board of Trustees has given consideration to these and all other matters and finds that the adoption of the within ordinance is in the best interest of the citizens of the Village of Tolono.

NOW THEREFORE, be it resolved by the Village of Tolono by its Board of Trustees at a duly held meeting this date as follows:

- 1. That a portion of property located on Daggy Avenue as is described on the surveyors report prepared by Berns Clancy and Associates dated June 7, 1996, a copy of which is attached hereto and by reference incorporated herein, is hereby vacated.
- 2. The Village clerk is hereby directed and authorized to arrange for recording of the within ordinance and provide a copy of same to Grand Prairie Co-Op. The Village Clerk is also directed and authorized to publish the within ordinance in pamphlet form and making same available for public inspection all is consistent with Illinois law.




