NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE OF TOLONO BY ITS BOARD OF TRUSTEES AT A DULY HELD MEETING HELD THIS DATE AS FOLLOWS:

1. That the property described on <u>Exhibit 1</u> is hereby Annexed to the Village of Tolono, Illinois and is now rezoned R-2 Residential District under the Tolono Municipal Code.

- b). Send notice of the annexation to the Village of Tolono Library, Park District and School District and the Champaign County Assessor and Treasurer of the aforesaid annexation.

LEGAL DESCRIPTION

SOUTHVIEW I SUBDIVISION

Commencing at the Northeast corner of the Northeast Quarter of Section 35, Township 18

North, Range 8 East of the Third Principal Meridian, Champaign County, Illinois proceed South 00'37'53" East along the East line of said Northeast Quarter, 291.72 feet (4.42 chains); thence North 89'19'10" West, 320.11 feet to the True Point of Beginning; thence continue North 89'19'10" West, 601.15 feet to the centerline of a public road; thence North 04'54'05" East along said centerline, 290.18 feet to the North line of said Section 35, said point also being on the South line of the existing Corporate Limits of the Village of Tolono, Illinois; thence South 89'27'51" East along said North line of Section 35 and said South line of the existing Corporate Limits, 591.13 feet; thence South 02'54'45" West, 291.111 feet to the True Point of Beginning, encompassing 3.970 acres more or less.
