ORDINANCE AMENDING THE WATER AND SEWER ORDINANCE OF THE VILLAGE OF TOLONO

WHEREAS:

1. The Village Board for the Village of Tolono is charged with preserving the health, safety, and welfare of the public and is otherwise authorized to implement and revise regulations involving the provision for water and sewer service to the benefit of its citizens; and

2. The Village has considered the costs and other related issues involved in providing water and sewer service to its citizens; and

3. The Village Board of Trustees has considered and approved the following amendments to its Water and Sewer Ordinance.

BE IT HEREBY ORDAINED BY THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF TOLONO, COUNTY OF CHAMPAIGN, STATE OF ILLINOIS, THAT THE VILLAGE OF TOLONO WATER AND SEWER ORDINANCE AS PREVIOUSLY ADOPTED IS HEREBY AMENDED AS FOLLOWS

Section 13.08.240

Paragraph 4 - Change cost for restoration of service during off-time hours and holidays from \$50.00 to \$100.00.

Section 13.10.110

Paragraph 1 - Delete the language in the second sentence and replace it with: "The water service line shall be sized in accordance with AWWA Manual M22, entitled "Sizing Water Service Lines and Meters," latest edition, and shall be not less than <u>one</u> (1) inch in diameter."

Paragraph 1 - Delete the fifth sentence in its entirety and replace it with: "Water service lines must have a minimum working pressure rating of 160 psi at 73.4 degrees F and shall be constructed of:

- 1. Copper water tubing, type K, conforming to ASTM Standards B-88 and B-251.
- 2. Polyethylene tubing, CTS, PE-3408, SDR-9, conforming to ASTM Standard D-2737.
- 3. PVC pipe, Schedule 40 minimum, conforming to ASTM Standard D-2241, NSF approved."

Section 13.20.210

Paragraph 2 - Amend fee for a permit and inspection for septic tank and underdrains from \$50.00 to \$100.00. Amend fee for a permit and inspection for a sewage disposal system other than septic tank and underdrains from \$150.00 to \$250.00.

Section 13.10.220

Paragraph 1, subparagraph 5: Delete this subparagraph in its entirety and replace it with: "All watermain extensions shall comply with Section 5.17 and all other applicable provisions of the Village of Tolono Subdivision Ordinance, as amended from time to time."

Paragraph 2, <u>Determination of who pays for watermain extensions</u>: Delete this paragraph in its entirety, and replace it with: "All watermain extensions constructed to serve new subdivisions or developments shall be paid for as described in Section 5.6.B of the Village of Tolono Subdivision Ordinance. The Village Board of Trustees may elect to install and pay the costs for replacing existing watermains or to construct new watermains to provide loops in existing developed areas, eliminating "dead-end" mains."

Paragraph 3: Delete this paragraph in its entirety, and replace it with: "All sewer main extensions constructed to serve new subdivisions or developments shall be paid for as described in Section 5.6.B of the Village of Tolono Subdivision Ordinance. The Village Board of Trustees may elect to install and pay the costs for replacing existing sewer mains."

Paragraph 13: Delete this paragraph in its entirety, and replace it with: "The size, slope, alignment, materials of construction of a building sewer, and the methods to be used in excavating, placing of the pipe, jointing, testing, and backfilling the trench, shall all conform to Sections 5.16, 5.18, and other applicable provisions of the Village of Tolono Subdivision Ordinance, as amended from time to time, as well as all other requirements of the building and plumbing code or other applicable rules and regulations of the Village of Tolono."

Paragraph 16: Delete this paragraph in its entirety, and replace it with: "The connection of the building sewer into the public sewer shall conform to the requirements in Section 5.18 and other applicable provisions of the Village of Tolono Subdivision Ordinance, as amended from time to time, as well as all other requirements of the building and plumbing code or other applicable rules and regulations of the Village of Tolono."

Paragraph 19: Delete the first sentence in its entirety and replace it with: "Connections to a mainline sanitary sewer shall be made at locations where prefabricated fittings are installed or at locations stated in Section 5.18 of the Village of Tolono Subdivision Ordinance, and then only in such manner as directed."

Paragraph 20: Delete this paragraph in its entirety, and replace it with: "All sanitary service sewers constructed to be connected to the Village Sanitary Sewer System, as well as building sewers, shall be constructed of materials specified in Section 5.18 of the Village of Tolono Subdivision Ordinance, as amended from time to time."

Paragraphs 21 and 22: Delete these two paragraphs in their entirety, and replace them with: "The construction of building sewers, materials, size, slope, and installation, shall be in accordance with Section 5.16, 5.18, and other applicable provisions of the Village of Tolono Subdivision Ordinance, as amended from time to time, as well as all other requirements of the building and plumbing code or other applicable rules and regulations of the Village of Tolono. Mainline sewers shall be extended beyond the last house, dwelling unit, or building to be served and shall end at the most distant property line of the last house, dwelling unit or building to be served, as measured from the sewer to which connection is being made. Building connecting sewers shall be installed or repaired by a licensed plumber, to have the installation or repair supervised by a licensed plumber."

Section 13.20.610

Paragraph 2 - Amend amount of fine for conviction of violation of provisions of the ordinance for each day of violation from \$100.00 to \$250.00.

Section 13.20.820

Paragraph 1, (1) - Amend the language in the first sentence to read as follows: "For a one (1) inch service connection to a Village water main: \$450.00."

Paragraph 1, (2) - Amend the language in the first line of the paragraph to read as follows: "The service connection fee for a new water service greater than one (1) inch in diameter and ..."

Section 13.20.830

Paragraph 1 - Connection charges for sewer service. Amend the rates to those listed in the following schedule:

Single residence:\$450.00 per connectionMultiple family dwelling:\$450.00 per connection plus \$100.00 per residential unitCommercial occupancy:\$700.00 per connection

In the fifth line of subparagraph (a), change the minimum charge from \$500.00 to \$1,000.00.

All other portions of said ordinance not otherwise amended shall remain in full force and effect.

The within ordinance shall be published in pamphlet form and shall be effective upon publication. The foregoing ordinance was passed, approved, and adopted by the Board of Trustees of the Village of Tolono, Illinois this 17th day of June, 1997.
