BE IT ORDAINED by the President and Board of Trustees of the Village of Tolono, Champaign County, Illinois, that the provisions of Chapter 10, Section 12 of the Municipal Code entitled "Traffic Control Regulations" shall be amended in the following particulars:

Section 10.12.040 Provisions and Regulations for Stopping at Designated Intersections. In addition to the traffic controls set forth in the current Ordinance as previously amended, the following shall also apply:

That all traffic traveling Easterly and/or Westerly on the following named streets as each such street intersects with Fourth Street (a North/South Street) shall stop at said: Boone Street, Larmon Street, Marshall Street, ~~Benham Street~~, Jackson Street and Broadway Street.

That all traffic traveling ^{Northerly} ~~Easterly~~ and/or ^{Southerly} ~~Westerly~~ on Cory Street shall stop at the intersection of Cory Street as it meets Holden Street (a ~~North/South~~ ^{East/West} street).

All other provisions of the aforesaid Ordinance shall remain in full force and effect subject only to the addition of the aforesaid requirement to stop at the intersection as indicated.

THIS ORDINANCE shall be effective upon passage.
