# VILLAGE OF TOLONO, ILLINOIS ORDINANCE CLARIFYING THE VACATION OF AND OTHERWISE VACATING A SECTION OF GREAT WESTERN AVENUE ORDINANCE NO. 01 - 8

WHEREAS, the Village of Tolono Planning Commission in a meeting held July 14, 1998 considered and recommended that a certain portion of Great Western Avenue be vacated with its findings incorporated herein; and,

WHEREAS, on August 18<sup>th</sup>, 1998, the Board considered vacation of the Avenue contemplated by the Tolono Planning Commission and in its ordinance No. 98-4 it appropriately referred to such vacation as constituting Lots, 1,2,3,4,&5 of Block 31 in Smith and Company's Addition by Whitehead whereas the planning commission, and the Board of Trustees intended, to vacate that portion of Great Western avenue adjacent to Lot 1,2,3,4 & 5 of Block 79 in Smith and Company's Addition by Whitehead to the Village of Tolono, Illinois; and

WHEREAS, the property owner of Lots 1,2,3,4 & 5 of Block 79 as described above paid the appropriate fee and is otherwise entitled to the corrected recording of said vacation and that no other fee was otherwise paid as related to 98- 4 such that the only vacation which is legally correct is the vacation of Lots 1,2,3,4 & 5 of Block 79 in Smith & Company's Addition by Whitehead to the Village of Tolono, Illinois.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF TOLONO, ILLINOIS:

**SECTION 1:** That portion of Great Western Avenue situated in Tolono, Illinois and adjacent to the following described properties is hereby vacated, concurrent with delivery by adjacent property owner of the attached utility, by reference incorporated herein:

Lots 1, 2, 3, 4, and 5 of Block 79 in Smith and Company's Addition by Whitehead to the Village of Tolono, Illinois situated in Champaign, Illinois.

SECTION 2: A prior unrecorded ordinance which was made in error, identified as "An Ordinance vacating a section of Great Western Avenue" and known as Ordinance No. 98- 4 adopted on the 18<sup>th</sup> day of August, 1998 is hereby repealed.

**SECTION 3:** Each lot owner shall execute an easement document granting access to the Village consistent to the easement document attached hereto and by reference incorporated herein.

**SECTION 4:** The Village Clerk is directed to publish this Ordinance in pamphlet form and this Ordinance shall be effective upon its passage and publication in accordance with law. Upon delivery to the Village by adjacent owners of a validly executed utility easement, the Village attorney is directed to record a copy of this Ordinance vacating said alleyway together with said utility easement with the Champaign County Recorder.
