ORDINANCE NO. $\underline{02-07}$ DESIGNATING THE VILLAGE OF TOLONO TAX INCREMENT FINANCING REDEVELOPMENT PROJECT AREA

TAX INCREMENT FINANCING DISTRICT

WHEREAS, the Village Board has heretofore in Ordinance No. <u>02.07</u> adopted and approved the Redevelopment Plan and Redevelopment Projects with respect to which a Public Hearing was held on March 11, 2002, and it is now necessary and desirable to designate the area referred to in said plan as the Redevelopment Project Area.

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE VILLAGE BOARD OF THE VILLAGE OF TOLONO, ILLINOIS, that the area described in Exhibit A-1 (Legal Description) and Exhibit A-2 (Map) attached to and made a part hereof is hereby designated as the Tolono TIF Redevelopment Project Area pursuant to Section 11-74.4-4 (65 ILCS 5/11-74.4-4) of the Tax Increment Allocation Redevelopment Act.

All ordinances and parts of ordinances in conflict herewith are hereby repealed.

This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
