#### AN ORDINANCE ADOPTING SCHEDULED BOARD OF TRUSTEES MEETINGS

WHEREAS, the corporate authorities of the Village of Tolono, Illinois, are the Village President and six elected Trustees; and

WHEREAS, the Board of Trustees has heretofore organized itself into several committees which consider various issues and projects and make recommendations to the Board of Trustees; and

WHEREAS, it is the ordinary practice of Tolono Village Trustees to attend all committee meetings, even those committees of which they are not an official members; and

WHEREAS, it is considered more efficient and in the public interest that the Board of Trustees hereafter abandon said addition committee meetings established for the primary purpose of which is to discuss, study and evaluate issues or projects before the Board of Trustees; and

WHEREAS, the current practice of conducting the business of the President and Board of Trustees at regularly schedule meetings thereof on the first and third Tuesdays of each month should be retained; and

WHEREAS, consideration of this Ordinance has been made with applicable notice and publication.

# NOW, THEREFORE, BE IT ORDAINED, BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF TOLONO, ILLINOIS, AS FOLLOWS:

The President and Board of Trustees shall hereafter ordinarily conduct its business and all committee meetings at its regularly scheduled meeting of the President and Board of Trustees on the following dates and times for the year 2003:
