**OF LIQUOR LICENSE**

**ORDINANCE NO. 04- 05**

**WHEREAS**, the Board of Trustees for the Village of Tolono, hereinafter "Village", is charged with the health care and welfare of its citizens; and

**WHEREAS**, the Village previously enacted the Tolono Municipal Code including, but not limited to, Chapter 5.04 regulating alcoholic liquor; and

**WHEREAS**, pursuant to the Illinois Liquor Control Act 235 ILCS 5\4-1 and other applicable provisions the Village has authority to provide for such regulation; and

**WHEREAS**, the Village has held various public hearings on consideration of an additional liquor license class and has determined it appropriate to create an additional classification for the sale of packaged liquor limited to the sale of beer and wine; and

**WHEREAS**, pursuant to said public hearings and consideration of all matters, the Village has determined it appropriate to create an additional Class F which will allow for the sale of beer and wine. In no instance shall the holder of a Class F license sell packaged alcohol which has an alcohol content in excess of 13% (26 proof) and no more than one (1) such license may be issued."

**NOW THEREFORE** be it hereby ordained by the Board of Trustees of the Village of Tolono as follows:

1. "Article IV. License" of Chapter 5.04 providing for the creation of licenses is hereby amended such that Section 5.04.202 shall have the additional class of license provided as follows:

"Class F. Packaged Beer and Wine Only. A Class F license shall permit the licensee to sell at retail beer and wine only which is not to be consumed on the premises. Notwithstanding the definitions of beer and wine as provided by this ordinance, in no instance shall the holder of a Class F license sell packaged alcohol which has an alcohol content in excess of 13% (26 proof) and no more than one (1) such license may be issued."

2. Section 5.04.203 providing for fees is hereby amended to read in total as follows:

"5.04.203. License Fees.

A. The Local Liquor Control commission shall receive from each applicant and license renewal applicant, as the case may be, the following license fee:

Class A	\$750.00 annual fee
Class B	\$450.00 annual fee
Class C	\$225.00 annual fee
Class D	\$350.00 annual fee
Class E	\$25.00 per day
Class F	\$450.00 annual fee

B. those licensees who remain open and sell alcoholic liquor on Sunday shall pay the following additional fees:


Class A	\$200.00
Class B	\$200.00
Class C	\$100.00
Class D	\$200.00
Class F	\$200.00

3. All other provisions of the above referenced chapter in addition to all other provisions of the Tolono Municipal Code as previously amended and not otherwise amended by this ordinance shall remain in full force and effect.

4. This Ordinance shall be effective immediately upon passage and shall be published in pamphlet form by the Village Clerk in accordance with applicable law.


