**AN ORDINANCE**  
**PROHIBITING DUMPING AT RECYCLING CENTER**

**WHEREAS:**

- A. The Village of Tolono is promoting the recycling of certain paper, cardboard, plastic, and aluminum products and has undertaken the installation of recycling containers for use by the public; and
- B. The recycling containers are being located at the west side of the parking lot adjacent to the Village Hall located at 507 S. Strong, Tolono, Illinois; and
- C. Signage will restrict the public to leaving only recyclable materials; and
- D. The Village desires to prevent the dumping of items and/or materials which are not accepted items at the site.

**NOW THEREFORE, BE IT HEREBY ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF TOLONO AS FOLLOWS:**

1. The Tolono Municipal Code is hereby amended to additionally include the following provision:

**“Section 8.400 NO DUMPING AT RECYCLING CENTER**

- 8.401. **Dumping Prohibited.** Wherever the Village has erected a recycling drop-off facility, members of the public shall only drop-off those materials which are designated as being accepted by appropriate signage. All such materials shall be put into the designated containers. It shall be illegal to deposit materials of any kind on the ground around such containers. It shall also be illegal to deposit any materials other than those deemed as accepted by signage into the containers and/or leave such materials in or around the recycling drop-off facility.

8.402. **Penalty.** Any violation of Section 8.401 above shall be considered Prohibited Dumping. Any individual found to have performed Prohibited Dumping in contravention of this Section shall be fined \$500.00.”

**BE IT FURTHER ORDAINED** by the President and Board of Trustees of the Village of Tolono, Illinois, that:

This Ordinance is effective this date upon, from and after its passage. The Clerk of the Village of Tolono is hereby directed to public this ordinance in pamphlet form.
