## TOLONO, ILLINOIS AN ORDINANCE AMENDING THE REVISED CODE OF ORDINANCES OF THE VILLAGE OF TOLONO AS IT RELATES TO THE ESTABLISHMENT OF WATER RATES ORDINANCE NO. 2010-O- \_\_\_\_\_

WHEREAS, the Board of Trustees of the Village of Tolono, Champaign County, Illinois, previously adopted the Revised Code of Ordinances as may have been subsequently amended, regulates water rates pursuant to Section 13.08.190 and other applicable ordinances for the Village of Tolono; and

WHEREAS, the Village provides its citizens water through its water system; and

WHEREAS, the Village purchases its water from Illinois American Water which previously raised its water rates; and

WHEREAS, the Board of Trustees and President have held public hearings and commissioned the Village engineers and engaged the services of a consultant to study water rates and have reached agreement upon rates which adequately reflect the cost of service and desire to adopt such rates as provided herein.

NOW, THEREFORE, BE IT HEREBY ORDAINED by the President and the Board of Trustees of the Village of Tolono, Illinois, that:

1. The water and sewer rates pursuant to Section 13.20.810, Paragraph 1, of the Revised Code of Ordinances, or as otherwise enacted, establishing water and sewer rates is hereby amended to read as follows:

"13.20.810 Rates-Water.

Paragraph 1: Rates for Metered Users

The following water and sewer rates shall be in force for all metered users:

a) Water Rates

For the first 2,000 gallons of water/month (or any fraction thereof): \$11.41

For all usage over 2,000 gallons of water/month \$5.70 per 1,000 gallons

b) Sewer Rates (exclusive of surcharges)
