AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE

REGARDING COLLECTIVE BARGAINING ADOPTED BY MAYOR AND VILLAGE
BOARD OF TOLONO, CHAMPAIGN COUNTY, ILLINOIS,
THIS 26TH DAY OF APRIL, 2011

WHEREAS, the Illinois Labor Relations Board certified the Teamsters Local 26 as the exclusive bargaining agent for all full time police officers employed by the Village of Tolono on June 11, 2007; and

WHEREAS, the Village and the Union have been bargaining in good faith to reach agreement and have reached a complete, tentative agreement and reduced it to writing as evidenced by Attachment A; and

WHEREAS, the Village believes the tentative agreement reached between the Village and the Union is in the best interests of the Village of Tolono; and

WHEREAS, in order to implement the provisions of the collective bargaining agreement with the police bargaining unit, it is in the best interests of the Village of Tolono that the Chief of Police be granted limited powers for resolving disputes which arise under the collective bargaining agreement.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND VILLAGE BOARD OF TOLONO, ILLINOIS, AS FOLLOWS:

SECTION 1: That the Village Board hereby ratifies the tentative agreement reached by the Village of Tolono's negotiating team and the Teamsters Local 26 and hereby authorizes the Mayor to execute a collective bargaining agreement between the Village of Tolono and the Teamsters Local 26 for the police bargaining unit as attached hereto and labeled Attachment A.

SECTION 2: That the Chief of Police is hereby granted authority to bind the Village of Tolono regarding issues which may arise under the collective bargaining agreement which do not have an impact on the Village's budget.

This Ordinance shall be in full force and effect after its passage, approval and publication as provided by law. The Village Clerk is hereby directed to publish this Ordinance in pamphlet form.
