DISORDERLY CONDUCT*

Sections:

9.08.010 Penalty.

9.08.010 Penalty. Any person who is guilty of disorderly conduct or of making any disturbance or a breach of the peace within the village shall, upon conviction, be fined not more than fifty dollars. (§2 of Ord. dated 6/13/1878).

Chapter 9.12

DISTURBING THE PEACE**

Sections:

9.12.010 Loud noises and offensive behavior.

9.12.020 Permitting loud noise.

9.12.030 Operation of radios, televisions and similar devices.

9.12.010 Loud noises and offensive behavior. Any person, firm or corporation who wilfully disturbs the peace and quiet of any neighborhood or family by loud or unusual noises or by tumultuous or offensive carriage, threatening traducing, quarreling, challenging to fight, or fighting shall be subject to a fine of not less ten dollars more than fifty dollars. (§1 of Ord. dated 11/2/53).

9.12.010 Permitting loud noise. Any person, firm or corporation who omits or who allows to be omitted from his premises, or from premises leased or controlled by him, any loud or unusual noise between the hours of ten p.m. and eight a.m. of the following day on each weekday, and

between the hours of eleven p.m. on Saturday and twelve noon on the following Sunday, shall be in disturbance of the peace and quiet of the village and shall be subject to the fine provided in Section 9.12.010. (§2 of Ord. dated 11/2/53).

9.12.030 Operation of radios, televisions and similar devices. Any person, firm or corporation who employs or allows to the employed on his premises, or on premises leased or controlled by him, any radio, television set, loudspeaker, public address system, music box, or other device which omits from said premises any loud or unusual noise between the hours of ten p.m. and eight a.m. of the following day on each weekday, and between the hours of eleven p.m. on Saturday and twelve noon on the following Sunday shall be in disturbance of the peace and quiet of the village and shall be subject to the fine provided in Section 9.12.010. (§3 of Ord. dated 11/2/53).

Chapter 9.16

UNLAWFUL ASSEMBLY*

Sections:

9.16.010 Collecting and failure to disperse--Penalty.

9.16.010 Collecting and failure to disperse--Penalty.
All persons who collect in crowds within the village for unlawful purposes or for any purpose to the annoyance or disturbance of citizens or travelers are subject to a fine of not more than twenty-five dollars and to a further fine of not more than fifty dollars upon refusing to disperse after being requested to do so by any village officer. (§5 of Ord. dated 5/13/1878).
