

Chapter 10.08ARTERIAL HIGHWAYS\*Sections:

- 10.08.010 Designated.  
 10.08.020 Full stop required before entering--Ex-  
 ception.  
 10.08.030 Rate of speed.  
 10.08.040 Penalty for violation.

10.08.010 Designated. Walnut Street, from the inter-  
 section of State Bond Issue Route 25 in the village to the  
 east property line of Second Avenue; Second Avenue, from  
 the north property line of Walnut Street to the south prop-  
 erty line of Vine Street; Vine Street, from the west prop-  
 erty line of Second Avenue to the east property line of  
 Bourne Street; Bourne Street, from the north property line  
 of Vine Street to the south line of the intersection of  
 Bourne Street and Austin Street; Austin Street, from the  
 east line of the intersection of Bourne Street and Austin  
 Street to the west property line of Vorcey Street; Vorcey  
 Street, from the south property line of Austin Street to the  
 north property line of Holden Street; and Holden Street,  
 from the east property line of Vorcey Street to the inter-  
 section of Holden Street and State Bond Issue Route 25, is  
 declared to be an arterial highway. (§1 of Ord. dated  
 11/4/35).

10.08.020 Full stop required before entering--Ex-  
 ception. Before entering upon arterial highways designated  
 in Section 10.08.010, the driver of any vehicle shall bring  
 the vehicle to a full and complete stop, except at the in-  
 tersection of said arterial highway of State Bond Issue  
 Route 25. (§2 of Ord. dated 11/4/35).

10.08.030 Rate of speed. The driver of every vehicle  
 traveling upon the arterial highway designated in Section  
 10.08.010 shall drive the vehicle at a rate of speed which  
 conforms to the laws of the state. (§3 of Ord. dated  
 11/4/35).

10.08.040 Penalty for violation. Any person violating either Section 10.08.020, Section 10.08.030, upon conviction thereof, shall be fined an amount not less than one dollar nor more than two hundred dollars. (§4 of Ord. dated 11/4/35).

## Chapter 10.12

### TRAFFIC-CONTROL REGULATIONS\*

#### Sections:

- 10.12.010 Erection of signs.
- 10.12.020 Penalty for violation.

10.12.010 Erection of signs. The streets and alleys committee of the board of trustees of the village shall cause appropriate stop signs and yield signs to be erected at the appropriate corners, which signs shall be maintained during the life of the ordinance codified in this chapter. (Ord. 77-4 §87, 1977).\*\*

10.12.020 Penalty for violation. The driver or operator of any motor vehicle who fails to come to a full stop at an intersection regulated by this chapter or who fails to slow the speed of his automobile to a speed reasonable for existing conditions and yield the right-of-way to any vehicle in the intersection, or approaching so closely so as to constitute an immediate hazard as set forth in the ordinance codified in this chapter, is guilty of a misdemeanor and may be fined not less than five dollars nor more than one hundred dollars. (Ord. 77-4 §86, 1977).
