## ORDINANCE NO. 93-1 AMENDMENT TO CHAPTER 8.12 through 8.24 NUISANCES, AS ADOPTED UNDER THE MUNICIPAL CODE OF THE VILLAGE OF TOLONO, AND AMENDED BY THE VILLAGE BOARD IN 1984 AND IN 1992 CHAMPAIGN COUNTY, ILLINOIS

## WHEREAS:

- 1. The Village Board for the Village of Tolono is charged with preserving the health safety and welfare of the public; and
- 2. It has enacted, and from time to time, has amended a Nuisance Ordinance under the foregoing Chapters of its Municipal Code; and
- 3. It has determined that the following amendments are in the best interest of the public in the preservation of health, safety and welfare.

Be it hereby ordained by the Village Board of Trustees of the Village of Tolono, County of Champaign, State of Illinois that:

- A. The following sections of Chapter 8.12 of the Municipal Code of the Village of Tolono are hereby repealed:
  - 8.12.100 relating to Abatement by Village permitted without conviction under certain circumstances
  - 8.12.190 relating to abatement by Village with due care
  - 8.12.200 relating to abatement by Village liability for costs
- B. The following portions of Chapter 8.24 of the Municipal Code of the Village of Tolono are hereby repealed:
  - 8.24.030(f) relating to abatement by Village

- 8.24.040 relating to cost of abatement by Village as a lien
- C. That Chapter 8.12.070 of the Municipal Code of the Village of Tolono is hereby amended to read as follows:

8.12.070 <u>Discovery by village policeman or trustee</u>. When any nuisance or any thing likely to become a nuisance is found by the policeman or any of the trustees, or is reported to them or either of then, the owner, author or cause of such nuisance shall forthwith be notified to abate, remedy or remove the same and, in case he should not comply with such notice, the Village may bring suit against the person in the name of the village, before any court having jurisdiction (§7 of Ord dated 5/21/1878).
