MINUTES OF THE VILLAGE OF TOLONO REGULAR BOARD MEETING JANUARY 5, 2016

The Regular Board Meeting of the Village of Tolono was held on January 5, 2016 and was called to order at 6:35 pm. Present were Board President Jeff Holt, Trustee Rena Anderson, Trustee Rob Murphy, Trustee Ryan Perry, Trustee Mike Golish, Trustee Jacquie Miller and Trustee Terrence Stuber. Clerk Dixie Phillips was absent.

The President led the Board and guests in the Pledge of Allegiance.

There were no comments from the public.

PUBLIC WORKS DEPARTMENT:

Bill Dawkins gave a report on the status of equipment in the Village. There was discussion about giving Bill authority to spend funds on items without advance Board approval. The Board gave direction to attorney Marc Miller to draft a policy for consideration at the next meeting.

Motion by Trustee Perry to authorize Bill Dawkins to spend up to \$2,000.00 to purchase a pump. Second by Trustee Golish. Roll call vote was taken and the following votes were cast passing the motion:

Engineer: Engineer Tim LaRocque gave an update on the installation of a guardrail. No bids have been submitted. Tim will work with President Holt to secure possible bids from other contractors.

Engineer Tim LaRocque gave an update on the roadway oiling and chipping issues. D.J. Stewart will be applying some cold patch to provide an interim fix which will need to be revisited when weather is better. The project was an IDOT project managed by the County. There appears to be no basis for holding prior contractors responsible for making the repairs.

There was no update on the CN RR (Holden Crossing). There was consensus to remove this from future agendas.

Zoning and Building: Building official Tony Battaglia handed out some information about planning for a truck route.

Zoning Administrator Randy Bachert gave a brief update.

There was discussion about the possible construction of a new police station.
