## **REPORTS**

**Engineers** – Larry Johnson said the Downtown Improvement Project is on pause, they need to look at roads for the MFT project, and there will be an EPA Audit May 9 regarding storm drainage.

**Public Works** – Todd Heath said they painted the handicap spot for the library and handicap signs have been ordered. They are just trying to keep up on mowing otherwise.

**Police Department** – Justin Levingston said the new squads are in use, he did a fundraiser for St Thomas in Philo to give a kid a ride to school, it was a busy weekend, and we lost 2 part-timers. Motion by Stuber, second by Buffo to enter into executive session at 7:14pm for the limited purpose of discussing the hiring, performance, compensation and/or employment of one or more specific Village employees 5 ILCS 120/2(c)(1) and acquisition of land 5 ILCS 120/2(c)(5). Roll call: Buffo, aye; Grady, aye; Haluzak, aye; Naas, aye; Robbins, aye; Stuber, aye. Motion passed.

The Board returned to regular session at 7:59pm and adjourned the meeting with a motion by Buffo and second by Stuber. Motion passed via voice vote.
