The Village of Tolono Board of Trustees ("Board") met on April 16, 2024 in the Police Station, located at 205 E. Main St., Tolono, IL. President Rob Murphy called the meeting to order at 6:32pm. Roll call found the following trustees present: Dan Grady, Ann Jack Haluzak, Jared Robbins, and Terrence Stuber. Trustee Jacob Naas was absent. Also present were Clerk Brandy Dalton and Public Works Superintendent Todd Heath.

All stood for the Pledge of Allegiance. Pastor Ken Young gave the invocation.

PUBLIC COMMENTS

Gary Mitchell stated his thoughts and concerns with the Downtown Improvement Project and the Village Board in general. He has scheduled a meeting at 108 E Main Street for May 7 at 6:30pm for the public to discuss their thoughts.

Maggie Kelly and Rachel Stewart discussed the loss of parking spots for the library with the current design of the Downtown Improvement Project.

Ken and Elaine Young also stated their concern with loss of parking in the design.

REPORTS

Engineers – Larry Johnson discussed the preliminary design of the Downtown Improvement Project.

Police Department – President Murphy said that the police have been doing more enforcement and have written 14 citations, 8 for speed, as well as 32 written warnings.
